## Organizational Overview

### Wyandot County Economic Development Mission:

The Wyandot County Office of Economic Development (WCOED) has been established to support growth of existing local businesses, recruit new businesses in targeted industrial sectors, advance the community's economic competitiveness, and ultimately improve the overall quality of life in the Wyandot County Area.

### Organizational Structure:

The organization is structured as a private / public partnership with support from the Board of Wyandot County Commissioners, City of Upper Sandusky, Village of Carey, Village of Sycamore, Wyandot Memorial Hospital, and numerous private sector businesses. The WCOED partners with the Wyandot County Board of Commissioners to fund a full-time Economic Development Director in Wyandot County. As such, the WCOED Executive Director also serves in a leadership capacity for the Wyandot County Regional Planning Commission. The combined offices are located on the first floor of the Wyandot County Courthouse.

### Fee Structure:

The Wyandot County Office of Economic Development Inc. operates as a 501(c)(6) non-profit business league with the mission of improving the economic viability in the Wyandot County area. *Dues and other payments to the organization are tax deductible to businesses as "ordinary and necessary business expense".* A WCOED Board Membership with voting rights is \$1,000.00 annually.
