### Sheetz Announces \$150 Million Investment In NW Ohio

### Company to Build New Food Preparation and Distribution Facility

Sheetz, Inc. has announced that it will construct a new \$150M facility in Findlay, Ohio that would house additional food preparation and distribution functions as the company expands its footprints into new markets. The project will create 750 jobs during the course of five years.
